BILL SUMMARY

Synopsis:

The amendment to SB 510 makes minor changes to the original bill. It eliminates “assessment misdemeanor, traffic violation and petty misdemeanor” from the title of the bill and adds the words “making an appropriation” to the end of the title. In the body of the Section 3 Crime Victims Reparation Fees, the terms “assessment misdemeanor, traffic violation and petty misdemeanor” are eliminated, thus specifying that only those convicted of a misdemeanor or felony offense are subject to the Crime Victims Reparation Fees.
